Essential Duties:

The primary duty of the position is to respond to alarms of fire and medical emergencies. The employee shall provide firefighting skills in accordance with NFPA 1001, Firefighter 1. The employee shall provide pre-hospital care in accordance with the State of Washington paramedic scope of practice and the requirements of the Clallam County Medical Program Director. The employee in this classification shall be able to work as a team member under the supervision of a Fire Lieutenant or Captain. The employee shall participate in training, fire prevention, physical fitness, and station and apparatus maintenance activities.

Qualifications:

- Be a United States citizen or a registered permanent resident alien with authorization to work in the United States
- Have a high school diploma or GED
- Must be 21 years of age before hire date
- Have current ACLS card
- Meet and maintain medical and physical standards of the position
- Successfully pass a background investigation
- Completed a minimum of one year employment as a career Paramedic
- Possess current Washington State Paramedic certification
- Pass a psychological evaluation prior to appointment
- Have a valid C.P.A.T. card by date of written test. (If currently working as a career FF/PM this requirement may be waived.)

Desirable Qualifications:

- Possess documentation of training to the level of NFPA 1001, Firefighter 1 and 2
- Possess Hazardous Materials First Responder training at an Operational level
- Associates or Bachelors

Application and Selection Procedures:

Beginning Tuesday, March 23rd 09:00 hrs, applications will be available on a walk-in basis at 323 N 5th Sequim, Washington or by calling 360-683-4242, during normal business hours. All application material shall be submitted to the administrative office of Clallam County Fire District 3 by **16:00 hours, Friday, April 16th**. Documentation to prove that the applicant meets the above listed qualifications shall be provided with the completed application. The applicant must also provide an abstract of driving record (available from Washington Department of Licensing) for at least the last 3 years. Resumes shall be submitted, but will not be submitted in lieu of a District application. Applicants will be screened for relevant education, training, experience and license as listed in the job announcement. The most qualified applicants will be invited to an interview process, written Clallam County Protocol Test and Practical Examination by the County Medical Program Director. An eligibility list will be established from the successful applicants. Upon receiving a provisional job offer, candidates will be required to participate in a psychological evaluation, medical examination and personal background investigation. Upon favorable results of the Drug test from the medical Examination, Psychological evaluation and background investigations formal job offers will be made.
