
## The City

Located in Los Angeles County's South Bay, Torrance borders the Pacific Ocean and beach communities to the west and the Palos Verdes peninsula to the south. Ideally situated near the 405 (San Diego) freeway and 20 minutes from the Los Angeles International Airport, Torrance occupies 21 square miles, including a beachfront and the Madrona Marsh, a fresh-water habitat. Torrance is within a 45-minute drive of many major Southern California attractions.

Incorporated in 1921 and chartered in 1947, Torrance has a population of nearly 147,000 and is the 12th largest city in California. Torrance is a full-service city with an annual budget in excess of \$200 million and a staff of over 1600 in 14 departments. The City has a council-manager form of government with an elected mayor and six council members.

The area enjoys a pleasant year-round climate with warm temperatures, gentle sea breezes and low humidity. The City boasts 46 parks and recreation amenities and six public libraries. The 502-seat James Armstrong Theatre in the Torrance Cultural Arts Center is an excellent venue for professional and local productions.

The community's population is culturally rich with an estimate of more than 80 languages spoken in local schools. Contributing to this diversity are such world-class international companies as Toyota Motor Sales U.S.A., American Honda Motor Company, Hi-Shear Corporation, Robinson Helicopter, Honeywell, Panasonic, and Virco Manufacturing, each of which call Torrance Home. ## FIRE PREVENTION SPECIALIST (JOB CODE 10043500)

We are seeking a career-oriented individual to ioin the Fire Prevention Division of the Torrance Fire Department. The Fire Prevention Specialist will, under supervision, participate in the inspection, plan checking, and testing of hazardous processes and fire protection and extinguishing systems to ensure compliance with applicable codes, ordinances, and standards. Additional duties include; assisting in related areas of the fire prevention and hazardous materials processes, code interpretation, Public Education and Field NPDES Compliance, Company training, Community Emergency Response Team (CERT) program coordination report writing, record-keeping, and other duties pertinent to the Fire Prevention Division.

#### **Desirable Candidate**

In addition to the minimum requirements, the ideal candidate will possess:

- An Associate's or Bachelor's degree in Fire Technology, Fire Protection Engineering or related field;
- Experience with fire-related and hazardous materials code enforcement in municipal government or in the industrial fire prevention field;
- Emergency Response and Public Education training and experience.

## **Minimum Requirements**

**Education & Experience**: Any combination of education and experience that provides the required knowledge and skills is qualifying.

Typical ways to qualify include:

- Equivalent to the completion of high school supplemented by college-level course work and or specialized training in Fire Science; and two years of progressively responsible experience in fire prevention including conducting inspections, plan checking and testing of hazardous materials processes and fire protection and extinguishing systems.
- An Associate's degree or a Bachelor's degree in Fire Technology Fire Protection Engineering or a related field is desirable.

Licenses and certificates: A valid California Motor Vehicle Class C Operator's license is required. HAZWOPER and P/C 832 certification will be required as a condition of employment and must be completed within one year.

#### Salary and Benefits\*

The hourly salary range is \$30.71- \$37.34 with excellent benefits:

The written examination (weighted 40%) is <u>tentatively</u> scheduled for May 28, 2010 and the oral interview (weighted 60%) is <u>tentatively</u> scheduled for June 15, 2010.
